## October Minutes & Treasurers Reports were eventually read & approved

Due to the many interruptions and chaos at the October meeting, it was announced that future meetings will be more tightly run by our current Meeting Procedures, which are on file, and Robert's Rules of Order.

When the October Minutes were read, an addition was noted by a resident that we needed to add that the residents were also upset by the need for more gravel on Old Korral Rd. This led to another long discussion which brought numerous other questions and replies. Since there had been discussions at previous meetings about many of these items, the Board decided that we could not discuss each one separately in the minutes. We will instead make a list:

- \* Complaints about Morello Construction. We answered (not to their satisfaction)
- \*Complaints about needed gravel and repairs on roads. We answered "Not enough Money". The only way to get additional funds is through a Tax Option( which the Residents voted down in 2011), a Grant, or a Bake Sale. We were told that a "bake sale" was a sexist remark!
- \* The Board not doing what residents requested for road repairs. We reminded members about the 2011 tax option that was voted down. Again-No Money!
- \* Our not initiating the 2 page suggestions. We answered they did not listen. Our Board members read and commented at Oct. meeting. That is why we voted to approve Jack's nomination at Oct. meeting.
- \* Questions about By Laws. We answered several times
- \* Questions about getting additional funds. We have answered many times.
- \* What are Boards Meeting Procedures? We answered, then discussed again.

The Board has discussed these at other meetings, some several times. The people we have e-mail addresses for have been requested to attend the meetings to give and receive important info. Very few have responded.

It seems that the only concerns of this group are to replace our current board and road contractor – and do it their way.
