I did not take 3ftW x 10ftL of the corner of Sunny Brook Rd and Burr.

I am requesting to have it changed to.

Property Dispute on corner of Sunny Brook and Burr Rd: Mr. Esqueda, reports he spoke to Board Member John Briggs on June 4th 2020. Mr. Esqueda informed John that the bank has been removed on the corner of Sunny Brook and Burr Rd. it appear to have been Plowed/Bladed away removing the pin and taking away approximately a 3x 10 portion of his property at the corner. Mr. Esqueda then asked John if the dirt from the

opposite side of the bank that has approximately 20 feet of additional dirt be moved to his side to repair the corner. Pictures were taken and Mr. Esqueda is currently having the area surveyed and has contacted the county about the problem.

According to

ORS 209.150¹

Removal or destruction of survey monument

- notice to county surveyor
- replacement of monument
- exception

• News Annotations Related Statutes

(1) Any person or public agency removing, disturbing or destroying any survey monument of record in the office of the county surveyor or county clerk shall cause a registered professional land surveyor to reference and replace the monument within 90 days of the removal, disturbance or destruction. The registered professional land surveyor referencing and replacing the monument shall do so in the same manner that is provided for public land survey corners according to ORS **209.140 (Necessary interference with corners or accessories)** and shall notify the county surveyor of that action within two business days. The costs of referencing and replacing the survey monument shall be paid by the person or public agency causing the removal, disturbance or destruction.

I am also requesting the resignation of John Briggs. John's conduct as a representative of our Road District was apprehensible. I did record some of his behavior and would be absolutely appalled if he treats other Road District Citizens like he did to me. His apparent lack of empathy towards this issue was not only disturbing but could result in other liabilities to the Road District if he were allowed to continue with his behavior. I feel that any further contacts with John will need to be recorded at the moment of contact. As a paying Road District citizen I do not feel comfortable with his continued work as a board member and should not have to feel the need to record our conversations. As a witness of his behavior I will now be required to testify if he has any issues with other residents that make claims against him or the Road District.
