New Business

There will be an opening for a 3 year board position, which will begin Jan. 1, 2020. The applications are available through the County, and are due back to the County no later than this coming November 1st, 2019.

Questions & Discussions

Questions were asked and answered re: when the County sends the taxes collected for our road district to our Woodland Park bank account.

We were again asked why we do not receive any compensation from the County for the use of others in the County using Old Korral Road on a regular basis, as it is also a County road.

We (again) covered the history of our road districts formation and the roads the County requires us to maintain. Due to changes in the State ORS Laws we can now only get additional funding through a Grant or a Tax Option which must be approved by the voters in our district.

Needed Repairs on Jet Ave. were again discussed. However, the last tax option which was on the ballot for repairs on Jet, was voted down unanimously by our residents.

As there were no additional items discussed, a motion was made and approved to adjourn. The Meeting was adjourned at 7PM.

THE WOODLAND PARK SPECIAL ROAD DISTRICT.


